Client Service Agreement

By signing this Credit Card/Direct Debit Request, you acknowledge having read and understood the terms and conditions governing the debit arrangements between you and Act for Peace-NCCA as set out in the Request and in your Direct Debit Request Client Service Agreement as follows:

Direct Debit Client Service Agreement:

1. We will deduct the amount that you have specified on the 20th day of each month until further notice from you. Your statement will show NCCA LTD.
2. When the due date falls on a non-business day, we will draw the amount on the next business day.
3. We will not change the amount or frequency of drawings arrangements without your prior approval.
4. We reserve the right to cancel the Act for Peace drawing arrangements if three or more drawings are returned unpaid by your nominated Financial Institution and to arrange with you an alternative payment method.
5. We will keep all information pertaining to your nominated account at the Financial Institution private and confidential.
6. You may terminate the act for peace plan drawing arrangements at any time by giving written notice directly to us, or through your nominated Financial Institution. Notice given should be received by us at least 14 days prior to the due date.
7. You may stop payment of a drawing under the act for peace plan by giving written notice directly to us, or through your nominated Financial Institution. Notice given should be received by us at least 14 days prior to the due date.
8. You may request changes to the drawing amount and / or frequency of the act for peace plan by contacting us and advising your requirements no less than 14 days prior to the due date.
9. Where you consider that a drawing has been initiated incorrectly you may take the matter up directly with us, or lodge Direct Debit Claim through your Financial Institution.
